# Modern Slavery Act Statement 2024

Additionally, we are dedicated to providing fair remuneration and guaranteeing compliance with applicable statutory minimum wage laws.

#### **Organisation Structure and Supply Chains**

Basetek Limited is a leading contract purchasing company, serving clients worldwide. Our organisational structure consists of various departments including Operations, IT, Marketing, Accounts and Warehousing. Our supply chains are extensive and global, encompassing the procurement of materials, components, and services from suppliers across multiple countries. We are committed to ensuring that our supply chains are free from any form of modern slavery or human trafficking.

### **Policies in Relation to Slavery and Human Trafficking**

Basetek Limited has a zero-tolerance policy towards modern slavery and human trafficking. Our Anti-Slavery and Human Trafficking Policy outlines our commitment to acting ethically and with integrity in all our business dealings. This policy is integrated into our Code of Conduct, which applies to all employees, contractors, and business partners. We provide comprehensive training on modern slavery and human trafficking to all employees, particularly those within our operations department involved in procurement and supply chain management. This training ensures that our staff are:

- Aware of the signs of modern slavery and human trafficking.
- Informed about the steps to take if they suspect any issues.
- Knowledgeable about our policies and their roles in upholding them.
- Equipped to engage with suppliers on these critical issues effectively.

### **Review and approval**

This statement is issued in compliance with section 54 of the Modern Slavery Act 2015 and pertains to Basetek Limited's financial year starting on January 1, 2023, and ending on December 31, 2023.
